**PLEASE READ THE FOLLOWING CAREFULLY BEFORE SIGNING**

1. This card entitles the bearer to priority entry to the Universal Bar, 221 William St Northbridge, known as The House of Blues and Jazz.
2. In addition, your purchase of the V.I.P card automatically places you on the Universal Bar mailing list to receive notification of any or all offers, discounts and promotions and invitations to special events.
3. Annual payment of \$10 only. Valid for one year from sign up date. A renewal form will be sent approx one month before membership expires.
4. You, the customer, acknowledge that, although we will take all reasonable steps to ensure you receive V.I.P entry at all times, we are a busy venue and as such are not free from our legal obligations, which include crowd control and overcrowding. Certain factors, such as unexpected crowds, pre-organised parties, maintenance etc. may mean you will not be allowed immediate admittance at certain times, but will always have VIP entry status over non VIP members.
5. We retain ownership of the Universal Bar V.I.P card. You must return this card to us immediately upon desire to sever your V.I.P membership and Mailing list status.
6. Please inform us immediately if you lose, or damage is caused to, your V.I.P card. Replacements will be made available at a \$5.00 charge.
7. You, the customer, agree that V.I.P status allows us to disclose all offers, discounts and promotions to you. In addition, any personal details loaned to us by you may be used at any time for system up-dates and customer recognition software programs.
8. The Universal V.I.P card cannot be transferred and can only be used by the authorised member.
9. We reserve the right to withdraw V.I.P membership at any time, should the cardholder not comply with Universal Bar rules and etiquette. Deviation from bar dress or behaviour codes will result in the voiding of V.I.P privilege.
10. V.I.P card entitles entry to cardholder and 1 additional guest ONLY. This is non-negotiable. Any deviation from this standard may result in termination of membership status. The member's guest must comply with all of Universal Bar's rules and must be over the age of 18years. The guest must produce ID if requested by management for proof of age.
11. Universal Bar's management and security reserves the right to refuse any member or their guest entry at any time if that member and/or guest refuses to comply with the rules and regulations of Universal Bar. The Bar also reserves the right to ask any member or members guest to leave the premises if they are not behaving in the correct manner, intoxicated or not complying to rules of Universal Bar.
